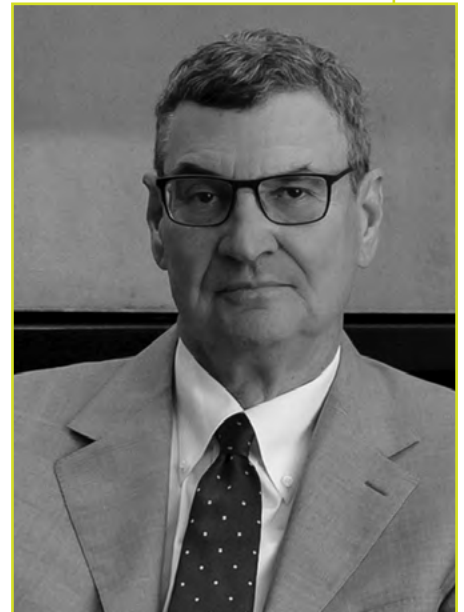
President's Message

2022 was marked by the decisive continuation of ACG's positive trajectory established over the past several years. Despite the Greek financial crisis, followed by the unexpected and unwelcome arrival of the Covid pandemic, ACG has grown in remarkable ways: quantity, quality and diversity of enrollment; academic program and faculty and staff development; campus expansion; constituency engagement and support; economic, cultural and social impact.

Especially notable in 2022 was the establishment of two new entities: the Pierce Pre-K, K and Elementary School and The American University of Greece in the Commonwealth of Massachusetts. 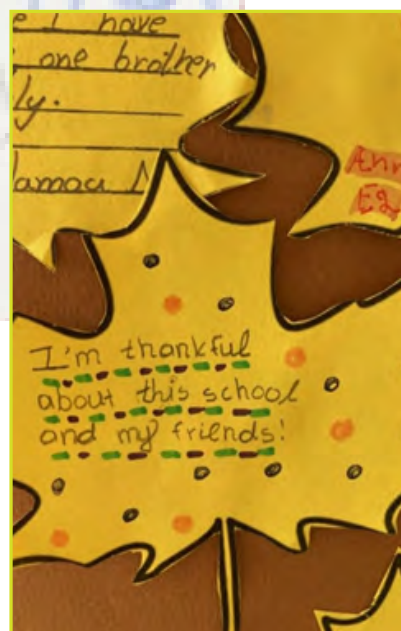


First Christmas Bazaar!

100 Years from Smyrna Catastrophe



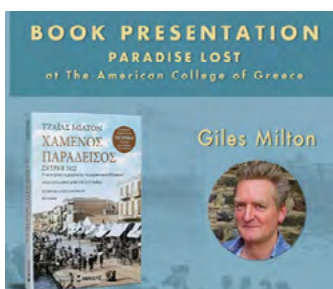
ACG Archives participated in the Benaki Museum exhibition ASIA MINOR HELLENISM: Heyday – Catastrophe – Displacement – Rebirth to commemorate the centennial anniversary of the Asia Minor Catastrophe. ACG's history is deeply rooted in Smyrna, and we have contributed to the exhibition's primary archival sources related to the tragic events of 1922.

At the Aghia Paraskevi campus, there is a special display about Smyrna at the College Library Digital Museum. There you will find two documents of an eyewitness account by Minnie B. Mills presenting a day-by-day narration of the catastrophic events.

Public events were organized as part of a tribute to Smyrna, "Remembering 1922: Commemorating the Asia Minor catastrophe – Honoring ACG's roots"

Acclaimed author and journalist, **Giles Milton**, presented the anniversary edition of his book *Paradise Lost* and engaged in a panel discussion on Smyrna pre and post the catastrophe with **S. Ploumidis**, Asst. Professor, History and Archaeology Dept. at the National and Kapodistrian University of Athens and moderator **Haris Vlavianos**, Deree Professor of History. (October 3, 2022)

Lou Ureneck, Professor of Journalism at Boston University, 2016 Eleftherios Venizelos Chair Lecturer and the author of "Smyrna, September 1922," presented a historical, comprehensive account of events in Smyrna during that calamitous month in 1922 and **Evanthis Chatzivassiliou**, Professor of Contemporary History at the University of Athens and the Secretary-General of the Hellenic Parliament Foundation for Parliamentarism and Democracy discussed the events of the refugee influx to Greece. Eleftherios Venizelos Chair Lecture 2022: "What's the story? History and the meanings of 1922"– A lecture by **Christine Philliou**, Professor of History and Director of the Ottoman and Turkish Studies and Modern Greek Studies Programs at UC Berkeley, in a commemoration of the loss of Hellenism in Asia Minor, presented the legacy by considering narratives, taken from contemporary sources, including the episodes in the story of Pierce College, and took us to Berlin, the US, and back to Western Macedonia, in an attempt to show how we can broaden our understanding by thinking historically and turning our attention ever so slightly in other directions. 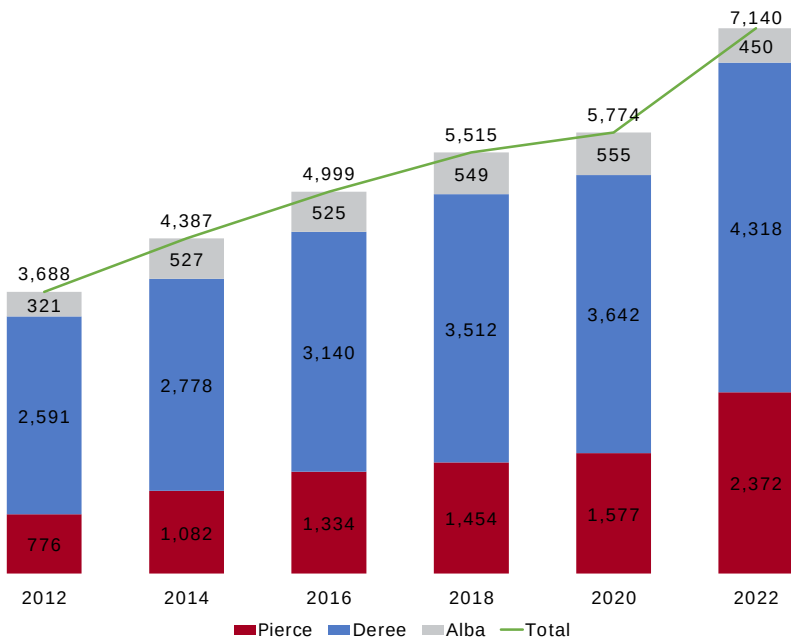

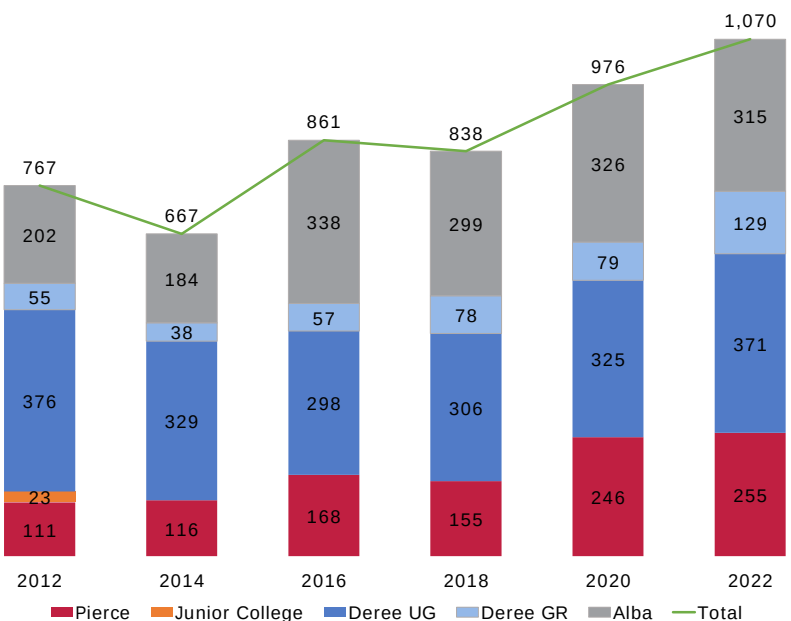
ACG FALL TOTAL ENROLLMENT



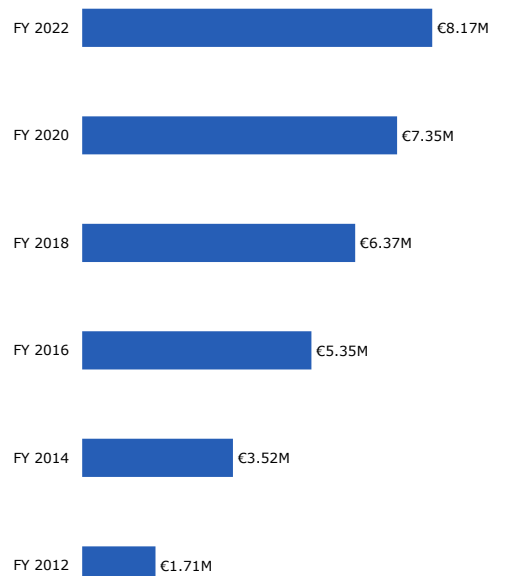

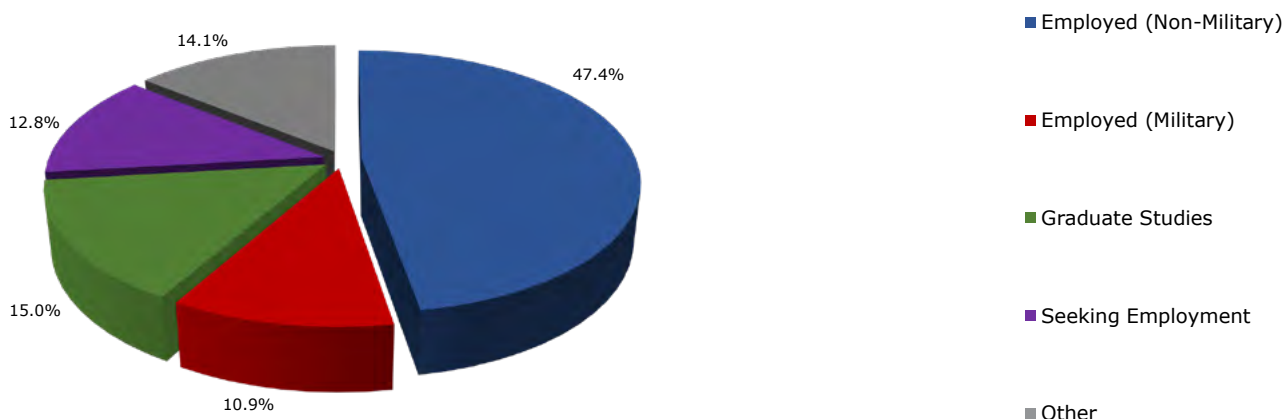

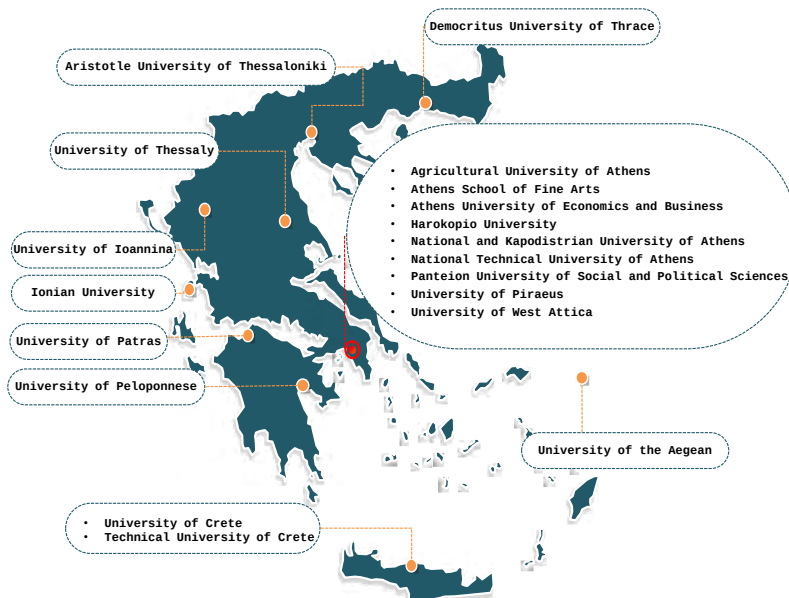
2022 GRADUATES - PLACEMENT AFTER SIX MONTHS



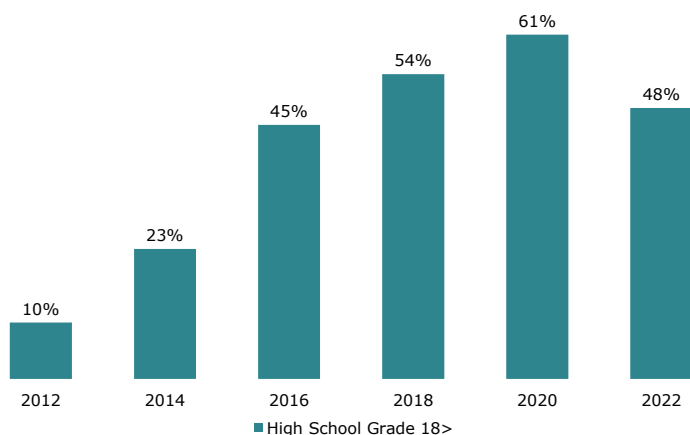

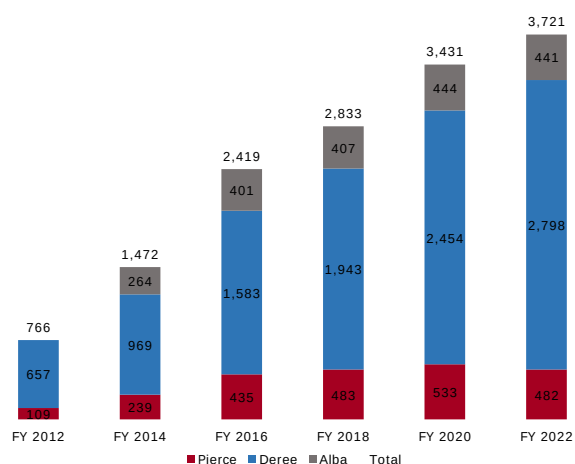

UNDERGRADUATE HIGH SCHOOL GRADE



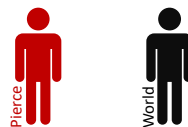

November 2022: The MSA Committee (Middle States Association of Colleges and Schools Commissions on Elementary and Secondary Schools) has accredited Pierce – The American College of Greece. A procedure, which normally requires 2 to 6 years, was completed for Pierce in the record time period of 1 year and 4 months (!), accentuating the outstanding human resources of the College and the excellent collaboration among the Administration, Teachers, Parents and Students, making Pierce the first national curriculum school in Greece to receive U.S. accreditation, and thus, strengthening its “American” identity.

Evelina Antemisari, B Lyceum student who studies at Pierce with a Music scholarship, participated in the **international piano masterclass** and concerts taught by the internationally acclaimed maestro and pianist Dimitri Toufexi (retired Deree professor). The event took place in Bologna – Italy from 7/3/2022 to 12/3/2022 and was organized by the “Associazione Mozart Italia –sede di Bologna”.



Athanasios – Nikolaos Stamou, Pierce Graduate 2022, conquered the **1st Place in the Panhellenic Competition** of Physics organized by the Panhellenic Physics Society.



Alica from the Ukraine, is studying at Pierce and is dreaming about the future once again!

Alica is the new student of the **IB DP Program** of Pierce, who came from the **Ukraine** and was offered hospitality, in the safe embrace of the American College of Greece. Going through the flames of war, the perils and the adversities, Alica started attending the 1st year of the International Baccalaureate Diploma Programme of the College.

“Now, I am dreaming about the future again, to study at the university, to learn new things, to make friends, to live a normal life. I don’t want to cry anymore... I am glad to see the flag of my country everywhere, but I know that it has to do with the war, with the refugees... I don’t know if I will ever be able to forget the bombardments, the shrilling sound of war sirens, and the fear. I have hope. I have dreams again, that can now come true!” Alica

Bronze Medal for 6 Pierce Students, members of the National Robotics Team of Greece

The Greek team created the Aethra Project, combining an innovative system with heat pumps and the cooling systems used by large hotel units, reducing electricity consumption and consequently the production of Carbon Dioxide. The Robotics Olympiad FIRST GLOBAL Challenge is a global robotics, science, innovation and technology event, in which national teams from 191 countries participate with children aged from 16 to 18 years old.



Pierce – The American College of Greece got the British Council International School Award – Full Accreditation 2022-2025, for the incorporation of international Best Practices in its curriculum.

In November, Pierce welcomed representatives from 67 universities from all over the world for a special event: the first ever International University Fair for undergraduate studies abroad.

The two-day event held on the main campus open to our middle school and high school community, over 1,600 students, as well as other private schools and the general public.

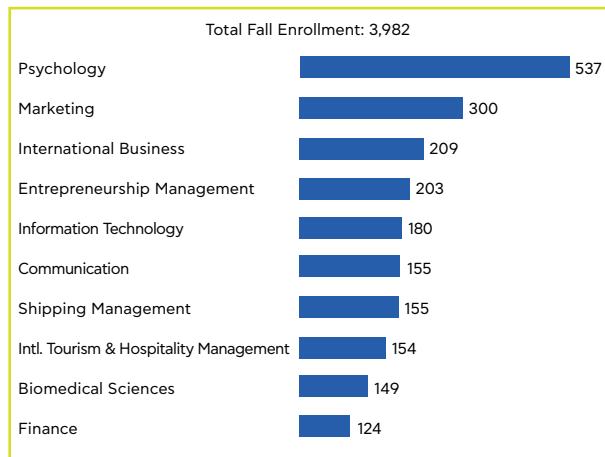

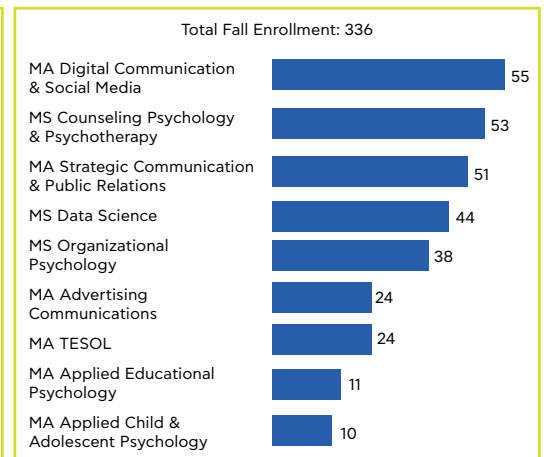

This is to inform you that at its meeting on Tuesday, October 18, 2022, the Massachusetts Board of Higher Education approved the application of the American University of Greece to incorporate in the Commonwealth of Massachusetts and to offer the following degrees:

The American University of Greece

On October 18, 2022, the Massachusetts Board of Higher Education (MBHE) approved The American University of Greece (AUG) as a new institution in the Commonwealth of Massachusetts, culminating a two-year application and review process. Massachusetts sets a high bar for its higher education institutions, which include some of the world's most prestigious – Harvard, MIT, Tufts, Northeastern, Boston College, Boston University. Being authorized by the Commonwealth of Massachusetts to award university degrees for study at ACG under AUG's institutional NECHE accreditation provides our graduates with an even stronger U.S. – and international – credential.

Deree Students Among Winners at X-Culture Competition!

Two Deree School of Business and Economics students in the International Business Cross-Cultural Management course, Ioanna Kylakou, a senior Shipping Management major, and Andreas Angelos Skondras, Parallel Study Leadership and Management minor, were members of one of the 13 winning teams receiving a 2022-23 X-Culture Best Team Award. 6,189 students from 140 universities in four countries participated on 1,289 teams. According to X-Culture, this was the first-ever participation from Greece!



New Vice President, Academic Affairs for The American College of Greece

In fall 2022, The American College of Greece welcomed Dr. Panos Vlachopoulos to the position of Vice President, Academic Affairs.

With an extensive record of research, teaching and administration, Dr. Vlachopoulos holds: a Ph.D., University of Aberdeen; Master's, Education, University of Manchester; B.A., Philosophy and Pedagogy, Aristotle University of Greece. He has published numerous scholarly works in the area of Education—with a special focus on the relationship between technology and learning. After holding positions in New Zealand, Hong Kong and the U.K., Dr. Vlachopoulos joined Macquarie in 2013, where he held a number of key administrative positions in the Faculty of Medicine and Health Sciences and the Faculty of Arts.

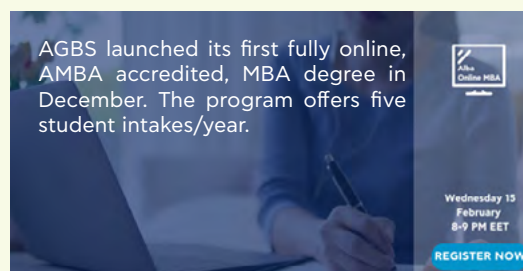

Implementation of the Deree Faculty Development Plan Phase One resulted in a change of status for 69 faculty members, reducing teaching loads of research-active faculty from eight to seven courses per year, and increasing the percentage of courses taught by full-time faculty to 79% (from 50%).

Dr. Charilaos Tsagkarakis, Pierce Lyceum and IB DP Physics Instructor, was selected as a recipient of the “2022 Yale Educator Award”. Dr. Tsagkarakis was nominated by Pierce IB graduate and current Yale student, Georgios Ploumis (IB 2022 Class Valedictorian - 45/45 score). 48 teachers and 29 counselors were selected to receive the award from 339 nominees, representing 43 US states and 21 countries.

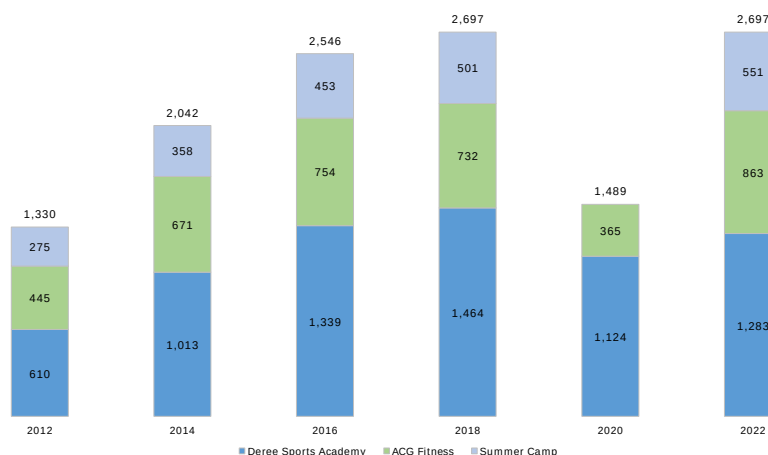

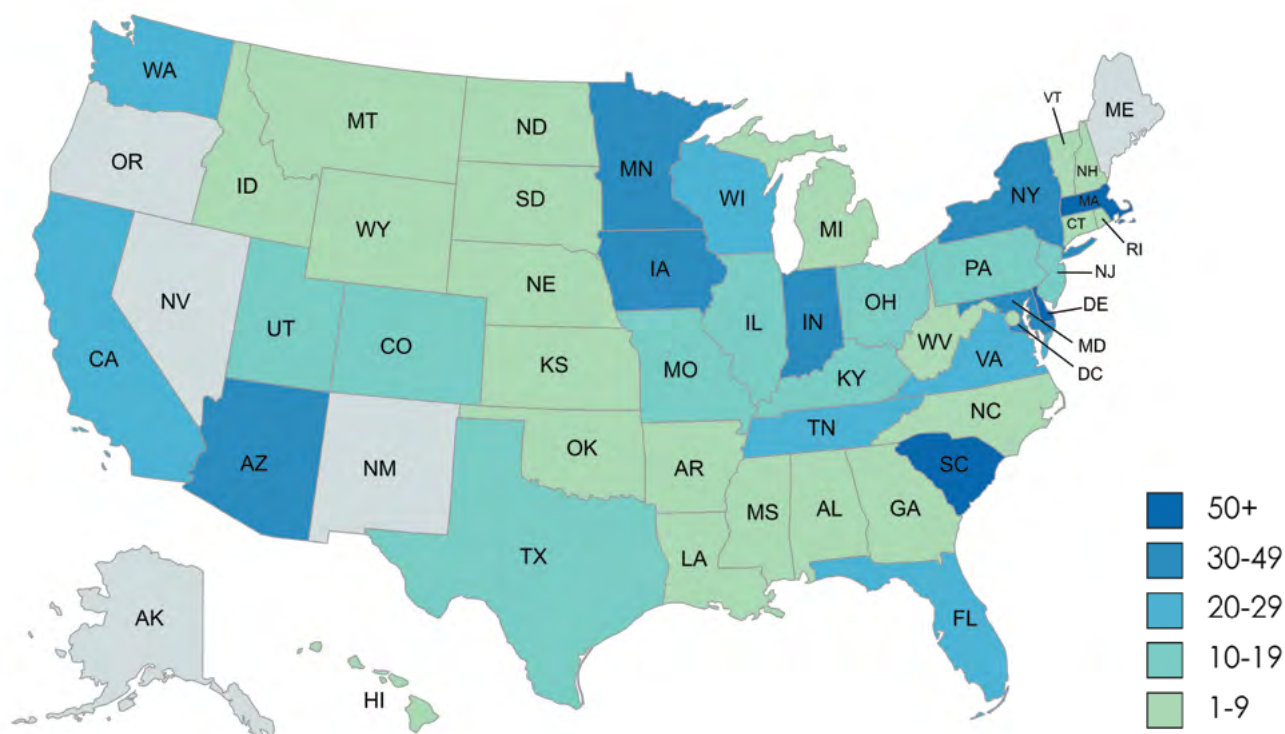

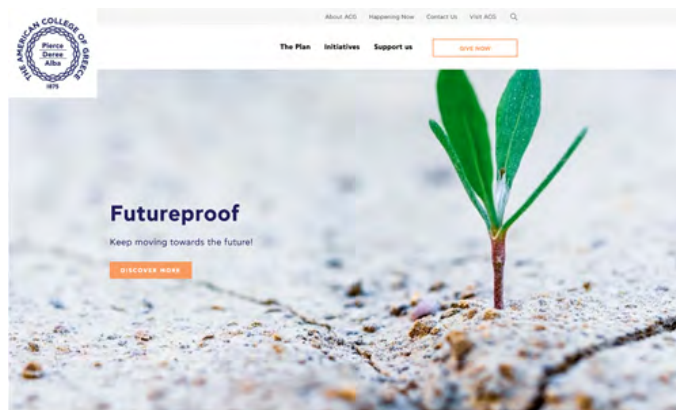
Dr. Babu's three-year PhD journey with ACG by his side

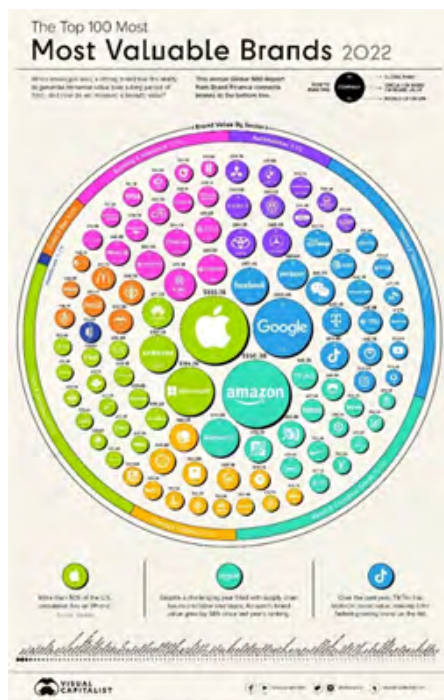
